ORDER

Whereas the West Bengal School Service Commission (Amendment) Act, 2012 has come into force with effect from 5th September, 2012;

Whereas *Ariadaha Monikuntala Balika Vidyalaya, Adyapeath, Dakshineswar, Kolkata- 76* under **Dakshineswar Ramkrishna Sangha Adyapeath** , P.O.- *Dakshineswar, Kolkata- 76*, represented to the State Government for being exempted from the provisions of the said Act and for having the authority to select and appoint teaching and non-teaching staff directly by themselves in order to maintain their age old benevolent traditions and being able to function by adhering to their lofty and philanthropic principles;

And Whereas *Dakshineswar Ramkrishna Sangha Adyapeath* , P.O.- *Dakshineswar, Kolkata- 76*, being a charitable organisation has submitted a copy of certificate vide No. DIT(E)/2386/8E/187/90-91, dated 05-05-2011 issued by the competent authority in respect of exemption under section 80G of the Income Tax Act, 1961 with perpetual effect;

Now, therefore, in exercise of power conferred by section 15A of the West Bengal School Service Commission (Amendment) Act, 2012, the Governor is pleased hereby to exempt the school as mentioned above under **Dakshineswar Ramkrishna Sangha Adyapeath** , P.O.- *Dakshineswar, Kolkata- 76*, from the purview of the said Act from the date of issuance of this order and will remain valid until further order according to the exemption under section 80 G of the Income Tax Act in favour of the organization and subject to the conditions that other terms and conditions of recognition issued by the West Bengal Board of Secondary Education shall remain unaltered and henceforth selection of the teaching and non-teaching staff against sanctioned and vacant post(s) of the institution shall be made by the school authority on the basis of minimum academic and other qualifications as stipulated in the prescribed rules framed under the West Bengal School Service Commission Act, 1997 and the procedure to be issued in this respect by the State Government from time to time.


